The Ministry of Agriculture and Forestry has obtained a loan from the World Bank to finance the expenditures under the TURKEY CLIMATE SMART AND COMPETITIVE AGRICULTURAL GROWTH (TUCSAP) PROJECT. A portion of this Loan will be used for the payments of the contract for which this Request For Expressions Of Interest is issued.

# 1. Background

The Turkey Climate Smart and Competitive Agricultural Growth Project (TUCSAP) aims to strengthen capacity for sustainable and competitive agricultural growth and to promote the use of climate smart agriculture in targeted regions in Turkey. The project supports the transition of the agricultural sector in Turkey to a more sustainable, competitive and climate smart orientation. TUCSAP is implemented by the Ministry of Agriculture and Forestry (TOB) through five General Directorates with a World Bank loan of 304,800,000 Euros (equivalent to 341.27 million USD) provided to the Republic of Turkey (TC). These General Directorates are the General Directorate of Agricultural Reform (TRGM), the General Directorate of Agricultural Research and Policies (TAGEM), the General Directorate of Information Technologies (BTGM), the General Directorate of Food and Control (GKGM), and the General Directorate of EU and Foreign Relations (ABDGM) serves as the Project Coordination Unit (PKB).

TUCSAP's activities are largely focused on developing institutional capacity to support competitive and climate-smart growth around the establishment of decision support systems for information generation and policy development on soil and land structure; development of laboratory and human resources for surveillance and diagnosis of animal diseases and control and regulation of veterinary drugs/vaccines; development of information systems and research capacity of the Ministry of Agriculture and Forestry. The project also supports the use of Climate-Smart Agriculture (CSA) technologies and innovative practices by farmers and agricultural enterprises.

## 2. Purpose of the Service

The mid-term review will focus on the approximately 35-month project approval and implementation period (March 2022-February 2025). The mid-term review is forward-looking and will effectively capture lessons learned and provide information on the nature, scope, potential impact and sustainability of the project. The review will assess the design, scope, implementation status and capacity to deliver expected results.

It will compile lessons learned, challenges and best practices from the implementation period that will inform the remaining years of implementation (March 2025-March 2028).

The emphasis on lessons learned addresses the issue of understanding what worked and what did not as a guide for future planning. The Review will evaluate the success of the project against the planned results. They will also assess preliminary indicators of the likely impact and sustainability of the results, including contribution to capacity development and achievement of sustainable development goals . The findings and recommendations of the Review will inform the implementing General Directorates of the Ministry of Agriculture and Forestry of opportunities to enhance project performance to ensure successful achievement of project development goals.
